One \$2,000 Carter Credit Union scholarship will be awarded. The winner will be announced and notified on **Wednesday, March 31, 2021.**

Eligibility

Applicant must be a student that is planning to enroll full-time in an accredited trade or technical college during the fall of 2021. The applicant or parent/guardian must be a member in good standing with Carter Credit Union with a minimum of two years of membership with the credit union.

Application Process

1. Eligible members must complete and sign the scholarship application and submit all requested documentation with the application. Please check off all documents as received.

2. The applicant and his/her parent or guardian must sign the Certification and Release Authorization section which is located on the last page of the application.

3. **The entire packet must be returned by the application deadline. If any portion is incomplete or required documents are not included, the application will not be considered.**

Selection Process

All applications will be based on both subjective criteria and weighted, objective criteria. These include academic performance, essay, community activities, part-time or summer paid or volunteer positions, personal goals as well as proper grammar usage and spelling. Each application will be evaluated by an outside agency to provide an unbiased decision. Once the scholarship recipient is chosen, the funds will be awarded to the applicant upon receipt of documentation showing the tuition due and payment will be sent directly to the school.

Application Deadline- All applications must be completed and mailed to the address noted and received by Friday, March 5, 2021. Applications not mailed directly to the address or received after 3/5/21 will not be eligible. Applications dropped at branch locations will not be accepted.
